

Since launch cumulative performance graph





Risk Profile

Moderate-High Risk

The Saffron BCI Flexible Fund outperformed on the quarter, returning -3.37% vs the ALSI dropping 4.79%. The relative short equity position was partially offset by losses on SA government bond positions at the very end of the quarter, however the outperformance of the target return remained strong.

The third quarter brought more volatility to a year that has been characterised by uncertainty and market instability. Barring the ECB, central banks finally put a pause to the hiking cycle but indicated that higher rates may continue for longer than previously expected. As a result, investors largely reduced exposures. EM currencies struggled at the end the quarter whilst the US Dollar Index (DXY) continued to strengthen. Similar moves were seen in global equity markets, as risky assets sold off.

Global markets were down across the board for the quarter, with Resources and EM markets being hit the hardest. Notably, the Hang Seng Index was down 5.85%, while the S&P also didn't escape the losses, down 3.65%. Japan remained a defensive market as the Yen depreciated.

Commodities were mixed over the quarter, with notable movers on the metals front being Gold down 3.64%, while Aluminium and Iron ore benefitted from increasing demand profiles, returning 10.42% and 8.21% respectively. Brent crude was the most significant mover, up 22.26% which will likely put upward pressure on inflation and hurt the consumer.

Asset classes on the JSE were mixed over the period, with the RESI20 again being the worst performer of the major indexes (returning -7.16% for the period) while the INDI25 returned -7.62%, as Gold, PGMs and China linked were down on the quarter. The standout over the quarter was the FINI index which remained defensive (returning 0.49%). Gold Prices were negatively affected by the prospect of continued higher rates and the strength of DXY, while global risk-off sentiment hurt cyclical metals (PGMs especially). Within the South African asset class universe, the top-performing asset class for the quarter was Cash (STeFI Index), which delivered a solid return of +2.05%. In contrast, nominal bonds (ALBTR Index) yielded a negative return of -0.36%, while inflation-linked bonds (CILITR Index) posted a slight positive return of +0.78%.

There were a number of notable corporate actions in the quarter, as Bob Van Dijk was replaced as CEO of Naspers under questionable circumstances, while in the small cap space, Transaction capital also saw its leader ousted, leading to a continuation of the slide observed over the last year. Neither move indicates a change in strategy at the companies and will likely not change the trajectory in the interim. Mid-caps were the darlings of the exchange, with notable performers being Liberty Two Degrees, Truworths and Sun International. Negative movers were highlighted by Gold Miners and Richemont.

During the quarter, the South African rand exhibited a slight depreciation of 0.39% against the USD, tracking the relatively flat trend observed in metals markets. Over a rolling one-year period, the USDZAR exchange rate experienced a decline of -4.63%, while the CRB Metals Index displayed strength, recording a gain of 2.67%. Additionally, the South African rand faced notable depreciation against other major currencies, including a -12.75% drop against the euro and a -14.25% decrease against the pound.

The Saffron BCI Flexible Fund slightly underperformed the peer group benchmark for the quarter (down 1.09% vs -0.74%). The fund remains ahead of the ALSI YTD and ahead of both benchmark and ALSI over a rolling year period.
